Mr. McMillan addressed the Board on his concerns with COVID testing and being able to be present when his student is being tested.

Ms. Sherman addressed the Board regarding concerns with the COVID vaccine and the potential of severe health issues and side effects.

Mrs. Gonzalez addressed the Board on her support for the district to continue following the guidelines on COVID and shared the loss of her husband to COVID.

Mrs. Stamos addressed the Board to urge all to continue upholding the state mandates and continue helping students and keeping all safe and healthy and again voiced her support for virtual meetings.

Mr. Higinio addressed the Board regarding the antagonistic behavior of some attendees, attendees not wearing masks and how COVID is real and affecting the Latino community of Fallbrook.

Mrs. Higinio addressed the Board regarding concerns that the only voices being heard are from the Caucasian community with no diversity in speakers and urged the Board to uphold the rules and mandates.
