• Financial Report

Brad Taylor reported on the financial standing of the school. The school is in a great financial position for this point in the school year. The discussion centered on the annual budget for the 2020-2021 school year, days cash on hand, and the move from FASB to GASB. The board thanked Academica West for their continual support with their financials. Ms. Schmidt agreed mentioning that she feels the school is in great hands with Academica West.
