Ms. Schmidt gave an update on the progress of the school reopening plan. The school is shifting as needed for students on quarantine. The hybrid model has been very helpful in minimizing the numbers of cases among the student population. The school is consistently evaluating how the models are working and what they can do better.

## • Financial Report

Brad Taylor reviewed the financial position of the school. The discussion focused on the current enrollment and how it impacts the school. Every school in Utah has seen a fluctuation of students coming and going due to COVID-19. The school is in a good position for this point in the school year.
