- **Financial Report** Brad Taylor reviewed the statement of activities as of the end of December. Federal revenue will be up for the year. Overall ELA is doing very well and is running in the black. The school is on schedule to end up with approximately \$201k. Brad also reviewed the statement of financial position. The school is currently around 112 days cash on hand. There are a lot of CARES act grants that are not reflected here. Eric asked if Brad had any concerns which he did not. Brad also mentioned that the legislation started yesterday and we are watching what is going on. He gave a summary of what items were going to be hot topics for schools which were tax receipts, Amendment G, and hopefully anticipating an increase in the WPU.

#### **VOTING ITEMS**

- <u>LEA Definition for "At Risk"</u> Stephanie asked Kim to go over this information. Kim informed the board that in the past the state allowed schools to use their definition of "at risk". Now the state would like each school to define "at risk". The school's recommended definition is "At Early Light Academy, at-risk of academic failure means any student who scores below proficient on a State or LEA approved assessment."
- <u>Director Evaluation Tool</u> Stephanie stated that this is the tool that was developed by her and Eric for Syd. When a new director is hired, it is good practice to approve the evaluation tool. Candice asked to Stephanie to give a bit more information on the tool. There are three areas that include leadership, finance and continual improvement for students and school professionals. The director sets specific goals with the board contingent on the schoolwide goals set by the board and administration team. These specific goals need to be set with a couple of board members and Stephanie. Then at the end of the year those goals are reviewed by the board committee and given a start, stop or continue for Stephanie. Eric reviewed the process of the director evaluation.
- <u>2021-2022 School Calendar</u> Stephanie stated that this is the annual calendar that Darci Cordero and Dawn have been working on to make sure that we have the right number of days and enough hours. This calendar is similar to this year's calendar. Stephanie also stated that we always take into consideration JSD's calendar. Dawn did mention that this calendar has the teachers working one less day which doesn't change anything but it will give the teachers daily rate a slight increase. Stephanie also added that their process for creating the calendar was that all staff that wanted to have a say in the calendar was invited to the calendar meeting. The admin team takes into consideration all of the feedback that is given by staff members.
- 2021-2022 School Fee Schedule There was no further discussion.
- Re-Approve Fee Waiver Policy There was no further discussion.
- Rescind the Employment of Substitute Teachers Policy Stephanie asked Kim to take the lead on this. Kim stated that this policy was put in place required by the state under a Utah admin rule. It has since been taken out as an admin rule so it is our recommendation to rescind the policy since it restricts you a little bit more than you need to be and the policy is not required.
- <u>LEA Educator Specific License for Zach Speed</u> Stephanie stated that Zach Speed was hired as a 5<sup>th</sup> grade teacher because Emily Johnson has moved to online teaching. This team has divided up the content of teaching. Zach has been a phenomenal substitute teacher for us. He has done everything but pass the Praxis test to become qualified so we will need to put him on an LEA-Specific license which the board will need to approve. Eric Montague made a motion to approve the proposed definition of an "at-risk" student in regards to EARS (Enhancement for At-Risk Students) funding; approve the Director Evaluation Tool with the caveat that we will form a two (board) member committee to evaluate the director; approve the 2021-2022 School Calendar; approve the 2021-2022 School Fee Schedule; re-approve the Fee Waiver Policy; rescind the Employment of Substitute Teachers Policy; and approve the request for an LEA-
