Approval of Minutes

Business Administration

- Fraud Risk Assessment Form Mandated by the state auditor's office each year, Rich has completed the form
 and received a score of 360 out of 395, putting GFA in the lowest risk category available. The Board was made
 aware of the score and Rich will submit the form.
- Action Items Board Approval
 - o FY 22/23 Original Budget
 - Steve made a motion to approve the FY 22/23 original budget with the discussed changes.
 Jamie seconded the motion, all voted in favor, motion passed.
 - FY 21/22 Final Budget
 - Steve made a motion to approve the FY 21/22 final budget as written in the handout, Jamie seconded, all voted in favor, motion passed.
 - Compliance Policy Every year the school is required to follow all applicable state and federal laws and regulations in the United States of American and the State of Utah.
 - Jamie made a motion to accept the Compliance Policy, Tom seconded, all voted in favor, motion passed.
- Finance & Accounting Report ending May 31, 2022
 - Summary: With 92% of the fiscal year concluded, the school is on track for a better-than-expected surplus for the year.

Administrative Update - Executive Director's Report

- Enrollment
 - o Enrollment on May 9, 2022 was 392.
 - GFA ended the school year with 392 students enrolled.
 - The current enrollment for the 2022/23 school year is 452.
- Discipline/Behavior Report
 - o There were 7 major office referrals for discipline in May
 - Four referrals were for threat intimidation
 - Two referrals were for inappropriate behavior
 - One referral was for aggressive behavior
 - There was 1 out of school suspension for ½ day.
- Attendance
 - o Average daily attendance for May was 91.72%.
 - Average tardy rate was 3.20%
- Academic Report
 - RISE and DIBELS testing Lisa reviewed test scores with the Board and reported how well GFA did and how they are above State scores.
- Personnel Update 2022/23 School Year everyone is coming back except for one (Librarian) that is retiring.

Policy/Strategic

- Enrollment & Lottery Policy Tabled to the August meeting.
- GFA Teacher and Student Success Framework for SY-2023 Lisa has made a few changes from SY 2022 and updated the Board on those changes.
 - Jamie made a motion to accept the GFA Teacher and Student Success Framework for SY-2023, Steve seconded, all voted in favor, motion passed.
- New Student Assessment Policy Lisa made a few changes and updated the Board on those changes.
 - Steve made a motion to accept the New Student Assessment Policy as written. Jamie seconded, all voted in favor, motion passed.
