**REPORT** 

Ms. Mefford presented a report on *Bond Expenditures*. She reviewed the items line by line for the current fiscal year, starting on page 5 at line 150 with the electrical power upgrades by Alpha Studio Design group in the kitchen building, through page 6, line 163, with the

STEAM lab classroom modernization by Ruhnau Clarke Architects. It was noted that page 5, line 152's payment to Balfour Beatty is the final payment for their involvement with the modernization project, and the Notice of Completion has been filed, marking that project complete. It was highlighted that the attorney fees with DWK have been split and are itemized so that they are only related to bond expenses.

Ms. Weishaar inquired about page 5, line 155, regarding the legal fees from Dannis Woliver & Kelley. She wanted a more detailed description of the fees. Ms. Mefford answered that the fees are for contract review, RFP review and specifically for finalization of the Balfour Beatty closeout documents.

Ms. Maier inquired about the process for choosing a vendor for items such as page 5, line 153: re-roofing the goat barn. Ms. Mefford explained that due to the price, we did not go to bid, but we compared quotes to find the best price before proceeding with the work.

Ms. Mefford noted that the spreadsheet has been updated as requested by the Committee with yearly and grand totals in a format that is easier to read.

#### PUBLIC COMMENT

The floor was opened for public comment, but there was none.

### ORGANIZATIONAL MATTERS

The floor was opened for any organizational matters that need to be addressed by the Committee. It was clarified that Ms. Powell will make sure that the FUHSD Board of Trustees will approve to fill the two vacant positions at their meeting on December 12, 2022, so that the Committee and proceed with filling the available seats.
