Administration is working with our web developer FrogTummy as well to revamp our website. Endeavor Hall is also advertising in City Journals, and Vista Print mailers.

- Teacher training: UPCS training, also professional development training at the school with 15-20 staff members present.
- Summer School: Interventions and reteaching activities will be July 26-August 6, 2021.
- Home Visits: Will be happening again this year through ZOOM. Teachers will be meeting with parents and students starting at the end of July.
- Maintenance: AC issues-two new air compressors coming for the north building. School closed for deep cleaning and maintenance.
- Staff: All teaching positions have been filled. We will be needing to hire paraprofessionals and recess help.
