2.1 In the event the Chromebook is damaged, lost, or stolen, the Student shall be responsible for paying the applicable repair or replacement costs as outlined below: 2.2 The Student will be responsible for the cost of parts to repair the Chromebook if the Chromebook is lamaged, but repairable. 2.3 If the Chromebook requires replacement during the first year (2023-2024) the cost will be \$270. 2.4 If the Chromebook requires replacement during the second year: (2024-2025) the cost will be \$180. 2.5 If the Chromebook requires replacement during the third year: (2025-2026) the cost will be \$90. 2.6 The replacement cost covers the purchase of a new Chromebook with similar specifications to the one nitially provided to the Student by the School.
3.1 If the power cord/charger provided with the Chromebook is lost, damaged, or rendered inoperable, the Student will be responsible for paying a replacement cost of \$60. 3.2 The replacement cost for the power cord/charger covers the cost of a new power cord/charger suitable for the provided Chromebook.
4. Exclusions: 4.1 The School will not charge any additional labor costs for the repair or replacement of the Chromebook or
charger. 4.2 The School will not be responsible for any data, files, or personal information that may be lost or damaged as a result of the Chromebook replacement or repair.
5. Agreement Duration and Termination: 5.1 This agreement shall remain in effect for the duration of the Student's enrollment at the School, or until the Student returns the Chromebook to the School in good working condition. 5.2 The School reserves the right to terminate this agreement and reclaim the Chromebook if the Student breaches any of the terms outlined herein.
