Funding for a student advocate, software purchases to supplement learning in mathematics and language arts, and funding to maintain current one-to-one Chromebook initiative goal.

Elementary: Goals: Increase the number of students reading at grade level as measured by the RISE assessment. Maintain assistants to provide small group reading instruction, intervention, and support. Increase math proficiency as measured by the RISE interim and benchmark assessments.
