## Alternative Credits Permission Form

- 1. Seniors who are planning on graduating in June <u>must</u> submit *Alternative Credits Permission Forms* to Counseling for course approval by **April 19**<sup>th</sup>. If a course needed for graduation is initiated after **April 19**<sup>th</sup> the credits will <u>not</u> be accepted.
- 2. Official Transcripts for Seniors planning on graduating in June are due to the Registrar's Office no later than **May 31**<sup>st</sup>. (Note: On average it takes most institutions at least two weeks processing time for official transcripts.)
